The Avalon Academy is a school dedicated to providing exceptional educational services to children with movement disorders such as cerebral palsy. In our highly-skilled and nurturing environment, we integrate academic and motor-skill development. Our individualized, interdisciplinary, and family-focused approach encompasses all areas of challenge for our students. This enables our children to fulfill their maximum personal potential, so that they thrive in both school and society.

Student Population

Students attending The Avalon Academy have significant motor impairment caused by disorders such as cerebral palsy. In addition to orthopedic impairments, our students generally have multiple disabilities which frequently coexist with motor disorders (for example cognitive, communicative, visual etc).

Although The Avalon Academy caters principally for children with cognitive impairment which co-exists with cerebral palsy, the school also provides a non-academic movement-based afternoon program one day a week for motor-impaired children with all ranges of cognitive abilities.

While The Avalon Academy readily caters for needs such as tube-feeding and routine seizure management, we are currently unable to accept students who require complex nursing care at school.

School Description and Mission Statement (School Year 2007-08)

Mission Statement

The Avalon Academy is a school dedicated to providing exceptional educational services to children with movement disorders such as cerebral palsy. In our highly-skilled and nurturing environment, we integrate academic and motor-skill development. Our individualized, interdisciplinary, and family-focused approach encompasses all areas of challenge for our students. This enables our children to fulfill their maximum personal potential, so that they thrive in both school and society.

Student Population

Students attending The Avalon Academy have significant motor impairment caused by disorders such as cerebral palsy. In addition to orthopedic impairments, our students generally have multiple disabilities which frequently coexist with motor disorders (for example cognitive, communicative, visual etc).

Although The Avalon Academy caters principally for children with cognitive impairment which co-exists with cerebral palsy, the school also provides a non-academic movement-based afternoon program one day a week for motor-impaired children with all ranges of cognitive abilities.

While The Avalon Academy readily caters for needs such as tube-feeding and routine seizure management, we are currently unable to accept students who require complex nursing care at school.

Programs

A variety of programs are offered to address each student's unique needs.

Full-Time Program

The full-time program focuses on functional skill development for cognitively-impaired students and runs from 9am until 3pm, Monday through Friday for 180 days a year. This program covers all developmental areas: academic, gross and fine motor, speech, communication, social, emotional and self-help.

Our approach is integrated and transdisciplinary to optimize learning for each child. Our team includes a movement intervention specialist, speech and language pathologist, assistive technologist and vision specialist whose services are integrated into the educational setting as appropriate for each student.

Movement Education Program

The movement education program runs from 3-5 pm on Thursdays, during the regular school year. This is a non-academic program which caters for children of all cognitive abilities. This program focuses on motor-skill development to foster functional movement and self-help skills. It also provides opportunities for children to develop their social and emotional competencies through peer support with other motor-disabled students, several of whom are "talkers".

Summer Program

The summer program runs for 6 weeks during July and August. It follows a similar format to the full-time program but with additional recreational-movement activities.

Reverse Mainstreaming Program

The Avalon Academy understands the importance of building social and emotional skills by interactions with typically developing peers. The reverse mainstreaming program fosters these interactions in our school and in community settings by organizing periodic visits by typical students from a local school. Siblings also regularly attend social events, both at Avalon and in the community.

Consulting Services

The Avalon Academy provides training and consulting services to school districts and their staff for students with multiple disabilities and orthopedic impairments. We offer support to general and special education teachers, inclusion specialists, adapted physical education specialists, instructional assistants and therapists.

We assist school districts with assessments of motor-disabled students and in the development of appropriate goals and objectives. Our staff also advise on handling and positioning techniques and the classroom adaptations necessary to

The Avalon Academy considers partnership with parents to be essential to the success of the school. The school welcomes parents to visit the classroom and provides a lounge area for informal meetings. Parents are especially encouraged to participate in workshops that occur throughout the year which provide opportunities for our students to participate in creative activities such as dance and art. Parties for the entire Avalon community also take place periodically to celebrate events such as holidays and birthdays.

Regular workshops are held which are aimed primarily at training parents and caregivers in a variety of topics related to the population served at The Avalon Academy. Hands-on techniques are demonstrated which can be used at home to facilitate handling and positioning of motor-disabled people. Techniques for lifting and transitioning are also explored to help protect caregivers from associated injuries.

Parent involvement is also an integral part to the fundraising activities of the school.

All staff members with direct contact with students are required to maintain First Aid and CPR certification as well as annual training in Universal Precautions.

The school has an annual Fire Inspection performed by Burlingame Fire Department. There is a fire warning system and fire extinguishers which are inspected annually. Fire drills are conducted in conjunction with the Burlingame Fire Department.

Each classroom has a fully-supplied First Aid kit and quick access to earthquake survival supplies maintained on the school site.

The philosophy of The Avalon Academy is to incorporate movement seamlessly into the daily classroom schedule. The Director of Education is a certified Practitioner in the Anat Baniel Method, based on the work of Dr. Feldenkrais. All classroom staff receive monthly training in movement education on an in-service basis at the school. Additionally, staff are encouraged to enroll in the offsite training course in the Anat Baniel Method to work towards certification.

Our staff also undergo in-service training weekly in augmentative communication so that they may better assist students in technology solutions for communication.
